- 1. Mayor Williams called the meeting to order at 7:00 p.m.
- 2. Roll was called with the following members present, Mayor Rhonda Williams, Christina Porath, Amber Wood, Kevin Bell, Gerald Young and Allen Cunnyngham.
- 3. Receive Request for Qualifications (RFQ) for a City Engineer and choose candidates for interview.

Each Council person was asked their choice of candidates to request an interview on July 11th. With candidates chosen, Christina Porath motioned to request DBI; Michael Wilson; and KSA to return on July 11th for interviews with Amber Wood seconding the motion. Motion carried unanimously.

4. <u>Receive Request for Qualifications (RFQ) for a City Attorney and choose candidates for interview.</u>

Each Council person was asked their choice of candidates to request an interview on July 11th. With candidates chosen, Christina Porath motioned to request Law Offices of Julian Grant; Messer, Rockefeller, Fort; and Brandon Shelby to return on July 11th for interviews with Gerald Young seconding the motion. Motion carried unanimously.

5. <u>Receive Request for Qualifications (RFQ) for a City Auditor and choose candidates for interview.</u>
