I. Introduction

The City of Blue Ridge, Texas invites qualified consulting firms to submit proposals for the development of a Comprehensive Plan that will guide the city's future growth and development. This Plan will serve as a strategic blueprint for land use, infrastructure, housing, public services, and community character, ensuring the City is prepared for anticipated growth and development pressures.

II. Community Background

Blue Ridge is a small but growing community in northeast Collin County, Texas. With its proximity to the rapidly expanding North Texas region, Blue Ridge is experiencing significant development interest. The City currently operates with a lean staff, including a City Administrator, City Secretary, Utility Clerk, Public Works Director, and three public works employees. With this limited staffing and infrastructure, it is vital that future planning is proactive, strategic, and community-centered.

III. Project Goals

The primary goals of the Comprehensive Plan include:

1. Land Use and Growth Management

- Develop a future land use plan to accommodate responsible, well-coordinated growth.
- Identify strategies for managing growth and preserving community character, including recommendations for annexation.

2. Infrastructure Planning

- Evaluate current and future needs for:
- Wastewater Treatment Plant (WWTP)
- Water wells, pump stations, and distribution systems
- Street and roadway improvements
- Public facilities, including a potential City Hall and Police building
- Provide recommendations for infrastructure upgrades aligned with growth projections.

3. Housing Development

- Recommend housing strategies that:
 - Promote larger lot sizes and quality residential neighborhoods
 - Improve community aesthetics and quality of life
 - Support affordable and attainable housing types

4. Zoning and Plats

- Review existing zoning ordinances and Planning & Zoning maps.
- Recommend zoning district updates and rezoning where needed.
- Identify opportunities for parcel replats or reconfigurations to support development goals.

5. Parks and Open Spaces

- Evaluate existing recreational assets.
- Propose future parkland and open space development to meet population needs.

6. Downtown/Main Street Revitalization

- Develop a vision and actionable strategies for revitalizing Main Street.
- Encourage business retention, streetscape enhancements, and public-private partnerships.

7. City Staffing and Organizational Growth

- Analyze current municipal staffing capacity.
- Project future staffing needs and provide an implementation plan for scaling city operations in line with growth.

The selected firm shall deliver a full-service Comprehensive Plan that addresses the goals above, and includes:

- Understanding of Blue Ridge's goals and constraints
- Relevant experience and qualifications
- Quality of previous work
- Approach to planning and community engagement
- Schedule and availability
- Cost effectiveness
